**4. First-aid measures**

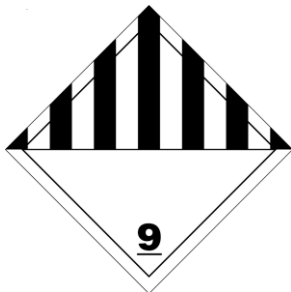
